- Sign in to account.kp.org and click "Documents." If you're not already registered, sign up at account.kp.org to start managing your account online.
- 2. Select one billing unit associated with the contract you want to access and click "Continue," then select "Go to all Coverage documents." The contracts are available under the "Contracts and Renewals" dropdown.



- 3. Select "Contracts Online." Your contract will be listed under the selected year dropdown. You can sort by column header to quickly identify the contract you want to view online.
- **4.** A PDF of your contract will open in a new window. You can search the document, save it to your computer, or print a hard copy.
