## PPO Plan<sup>1,2,3</sup>



PPO stands for 'Preferred Provider Organization.' The PPO plan may be the right option for you if you or your family live outside a Kaiser Permanente service area.

The PPO Plan Participating Provider Network (also referred to as In-Network) includes the First Health® Network when you get care in Colorado and other Kaiser Permanente states (CA, GA, HI, MD, OR, VA, WA, and the District of Columbia), and the Cigna Healthcare<sup>™</sup> PPO Network<sup>4</sup> when you get care outside a Kaiser Permanente state.

# With this plan, you have the freedom to spend your health care dollars as you see fit.

If you get care in our In-Network/Participating Provider Network, you'll pay less, and your provider will manage authorizations and submit claims on your behalf.

You can also choose to go outside our In-Network/ Participating Provider Network to see any licensed provider you want. If you choose to get care from an Out-of-Network/Nonparticipating Provider, your out-of-pocket expenses may be higher, and you may need to file your own claim to be reimbursed.

If you fill your prescriptions at an in-network/ participating MedImpact pharmacy anywhere in the country, you will pay less. You can also fill your prescriptions at any pharmacy of your choice outside the MedImpact network. If you choose a non-Medimpact pharmacy, you'll pay more and you will need to submit your own claim.

**Note:** Not all services are covered in each tier. Please consult your plan documents or contact Customer Service for any questions regarding your benefits.

#### Finding a provider<sup>5</sup>

To find a list of in-network/participating providers:

- Or call Customer Service for more information and assistance.

You may change doctors at any time; that's entirely up to you. And you don't need a referral to see a specialist. If, however, the specialist you want to see is outside our In-Network/Participating Provider Network, your plan's Out-of-Network/Nonparticipating Provider Tier benefits will apply, and you'll have to submit a claim for reimbursement. #### **Prior approval**

#### **Precertification of Medical Services**

As a KPIC PPO plan member, you may need to get precertification for certain covered services from Out-of-Network/Nonparticipating Providers. We've partnered with Permanente Advantage to help ensure that medical services ordered by your doctor are medically necessary, cost-effective, and the most appropriate treatment for your condition. Before you receive certain treatments, tests, or procedures, you or your physician should request precertification as soon as reasonably possible.

#### Finding a pharmacy

This plan entitles you to coverage for prescription drugs through the MedImpact pharmacy network, which includes many local and national pharmacy chains, including pharmacies at Albertsons, King Soopers/ City Market, Kmart, Sav-on, Medicine Shoppe, Safeway, Sam's Club, Costco, Target, Walgreens, and Walmart.<sup>6,7</sup> To verify whether a specific pharmacy participates, or to obtain a complete list of in-network/participating pharmacies, call MedImpact at **1-800-788-2949** (TTY **711**).

You also have the option of choosing an out-of-network/ nonparticipating pharmacy (outside of the MedImpact network), in which case, you'll pay full price and file a claim for reimbursement. Claim forms can be found at: **kp.org/ppo-colorado**.

### Prior authorization of outpatient prescription drugs<sup>8</sup>

As a KPIC PPO plan member, you may need to get prior authorization for certain outpatient prescription drugs. We've partnered with MedImpact to help ensure that outpatient prescription drugs ordered by your doctor are medically necessary, cost-effective, and the most appropriate treatment for your condition. Before you receive certain outpatient prescription drugs, your physician should request prior authorization by completing and submitting the KPIC Prior Authorization in writing.
